### Questions About Spirit Contact

**Q: What is the difference between a psychic and a medium?**

**A:** A psychic can “read a person’s energy” and may see past, present, or future events in that person’s life. A medium communicates directly with spirits. Mediums however, also possess psychic ability. It has been said that every medium is a psychic, but not every psychic is a medium.

**Q: Is contacting a spirit frightening?**

**A:** No, and that is because love transcends physical death. When spirit contact is a conversation with someone you love, the spirit who loves you is not going to upset you.

**Q: What do you do as a medium?**

**A:** I help people connect with their loved ones who have passed to “The Other Side.” I don’t conjure or summons spirits, what I do is connect with a spirit who wants to be perceived. Many people find spirit contact to be a therapeutic tool in the healing process.

**Q: What is a “contact experience?”**

**A:** Contact experiences occur when spirits communicate with us. These include: sensing the presence of a deceased loved one, seeing or hearing a loved one who has passed, unexplained electrical phenomena, or objects of a sentimental nature which are somehow connected to the deceased loved one being moved with no rational explanation of how that object was moved.
